



EXECUTIVE ORDER NO. 2017- 04

AN ORDER REORGANIZING THE MUNICIPAL TOURISM, CULTURE AND ARTS COUNCIL (MTCAC) IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN

WHEREAS, the Municipal Government of Marilao recognizes the important role of culture and the arts in shaping the Municipality's history;

WHEREAS, the steadfast development of the Municipality of Marilao into a flourishing local government unit today is influenced by its cultural heritage, history and the ingenuity of its people;

WHEREAS, the preservation and enrichment of our cultural heritage can be achieved through collaborative efforts of all stakeholders;

WHEREAS, Section 16 of the Local Government Code (R.A. 7160) provides that LGU plays an important role in the preservation and enrichment of Filipino culture and identity;

WHEREAS, pursuant to Section 17 (2) (xi) and (3) (xii) of the Local Government Code (R.A. 7160), local government units shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities of their local tourism facilities and other tourist attractions, including the acquisition of equipment, regulation and supervision of business concessions, security services for such facilities, and for tourism development and promotion programs;

WHEREAS, Section 447 (5) (xvi) of the Local Government Code (R.A. 7160), vest upon local sanggunians the power to establish local councils whose purpose is to promote culture and the arts, coordinate with government agencies and non-governmental organizations and, subject to the availability of funds, appropriate funds for the support and development of the same;

WHEREAS, DILG Circular 95-162 and DILG Memorandum Circular No. 2002-81 mandates all Local Chief Executives to organize a local tourism, culture and the arts councils.

NOW THEREFORE, I, JUANITO H. SANTIAGO, Municipal Mayor of Marilao, Bulacan, by virtue of power vested in me by pertinent laws and rules, do hereby order the following:

Section 1. COMPOSITION. The Municipal Tourism, Culture and Arts Council (MTCAC) shall be composed of the following:

Section 2. FUNCTIONS. The MTCAC, through the leadership of the Municipal Mayor shall:

- a. Formulate programs and recommendations to develop local tourism facilities and attractions tapping local resources and funds.
- b. Assist in the regulation and supervision of tourism-oriented establishments thereby ensuring wholesome and clean tourism activities.
- c. Ensure that local talents, artistry and ingenuity are encouraged, developed, supported and recognized.
- d. Promote the Filipino culture, instill nationhood, cultural unity, and raise the level of consciousness of the people on cultural values and conservation of historical and cultural heritage.
- e. Assist in monitoring the implementation of the Local Government Code on the matter of licensing of tourism establishments in the locality to ascertain safe and enjoyable stay of travelers.
- f. Perform other functions as may be necessary to ensure that local tourism, culture and arts are given due importance.

Section 3. SECRETARIAT. The Secretariat is hereby designated to provide administrative and technical support to the Council:

Section 4. REPEALING CLAUSE. All other rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

Section 5. EFFECTIVITY CLAUSE. This order shall take effect immediately.
