



EXECUTIVE ORDER NO 2017-09

REORGANIZING THE MARILAO RIVER INSPECTION, INVENTORY AND MONITORING TEAM IN THE MUNICIPALITY OF MARILAO, BULACAN

WHEREAS, on 15 February 2011, the Supreme Court issued En Banc Resolution in *MMDA vs. Concerned Residents of Manila Bay*, G.R. Nos. 171947-48, which ordered concerned departments and agencies of the national government to conduct specific activities for the cleanup, rehabilitation and preservation of Manila Bay and its adjoining river systems and waterways;

WHEREAS, in compliance with said Supreme Court En Banc Resolution, the Department of the Interior and Local Government (DILG), through its Director of Regional Office No. 3, DIR. FLORIDA M. DIJAN, issued Regional Memorandum Circular No. 2011-08, which advised the governors and mayors within the region to organize their respective inspection, inventory and monitoring teams.

NOW THEREFORE, I, JUANITO H. SANTIAGO, Municipal Mayor, by virtue of the powers vested in me by law, do hereby ORDER:

Section 1. COMPOSITION. The Marilao River Inspection, Inventory and Monitoring Team, hereinafter referred to as the TEAM, is hereby reorganized, to be composed of the following:

Section 2. DUTIES AND RESPONSIBILITIES. The TEAM shall have the following duties and responsibilities:

- a. Conduct inspection and inventory of all factories, commercial establishments and private homes within and outside the easements along the banks of Marilao River and waterways adjoining said river, within the territorial jurisdiction of Marilao, Bulacan, to determine if they have wastewater treatment facilities and/or hygienic septic tanks, as prescribed by existing laws, ordinances, rules and regulations;

- b. Prepare and submit duly certified lists of the following, not later than the 5th day of the ensuing month after the end of the quarter:
- Names and addresses of all non-complying factories, commercial establishments and private homes along the banks of Marilao River and waterways adjoining said river, within the territorial jurisdiction of Marilao, Bulacan;
 - Names and addresses of all private homes along the aforesaid banks and waterways;
 - Names and addresses of the informal settlers who, as of September 30, 2011, own or occupy houses, structures, constructions and other encroachments built along the aforesaid banks and adjoining waterways;
- c. Monitor the compliance of non-complying factories, commercial establishments and private homes along the aforesaid banks and adjoining waterways;
- d. Recommend to the Municipal Mayor the imposition of necessary sanctions and penalties for all non-complying factories, commercial establishments and private homes along the said banks and adjoining waterways;
- e. Prepare and submit Quarterly Report on Key Performance Indicators (KPIs) Compliance and LGU Five Year Action Plan Implementation starting June 2018 and December 2018 respectively;
- f. Perform other tasks that may be assigned from time to time relative to the implementation of the Manila Bay Clean Up, Rehabilitation and Preservation Project.

Section 3. SANCTIONS. Failure or refusal without justifiable cause by any of the members to perform any of the foregoing duties shall be a ground for imposition of administrative sanctions against the erring official/employee.

Section 4. REPEALING CLAUSE. All other orders, rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

Section 5. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
