



EXECUTIVE ORDER NO. 2018 - 04

**REORGANIZING THE MARILAO MUNICIPAL ANTI-DRUG ABUSE COUNCIL
(MADAC) IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN**

WHEREAS, the Local Government Code provides that local government units shall pursue undertakings to improve public moral and maintain peace and order;

WHEREAS, drug abuse is one of the major problems in our society, especially among the youths, thereby posing threats to the peace and order situation;

WHEREAS, the national government, through several issuances, has enjoined the local government to support the fight against illegal drugs and work for drug-free communities;

WHEREAS, the municipal government, in unison with the national goals, felt the need to create a council that will effectively formulate, recommend, coordinate implement and monitor measures, programs and activities that will ensure a drug-free Marilao;

NOW, THEREFORE, I, JUANITO H. SANTIAGO, Municipal Mayor of Marilao, Bulacan, by virtue of the powers vested in me by law, do hereby **ORDER**:

Section 1. COMPOSITION. The Marilao Municipal Anti-Drug Abuse Council (MADAC) is hereby reorganized as follows:

Section 2. DUTIES, FUNCTIONS AND RESPONSIBILITIES OF THE MADAC. The MADAC shall perform the following duties, functions and responsibilities:

- a. Convene concerned organizations or sectors in the cooperative planning, implementation and evaluation of various programs on drug abuse prevention and control;
- b. Provide effective mechanism for coordination and alignment of existing services and programs that will complement planned or future programs;
- c. Submit monthly monitoring report to the Provincial Anti-Drug Abuse Council;
- d. Conduct information and education campaign that would ensure the participation and involvement of the entire community in the implementation of drug abuse prevention and control;
- e. Institute mechanism to obtain support from all stakeholders by way of recruitment of volunteers, technical support, facilities and financial grants that would assist in addressing comprehensively the drug problem in the municipality;
- f. Prepare a confidential watch list of drug users and pushers found in the LGU's area for verification leading to the arrest and filing of appropriate charges;
- g. Recommend to the Sangguniang Bayan, the allocation of budget for the effective implementation of the drug prevention programs and activities;
- h. Submit to the Municipal Mayor periodic report on the implementation of drug prevention programs and other related activities; and
- i. Perform such other functions as may be required by competent authorities to ensure a drug-free Marilao.

The MADAC shall meet regularly to discuss and resolve issues relating to drug prevention and control.


Section 3. FUNCTIONALITY INDICATORS. The MADAC shall be assessed in the following areas:

- a. Organization
- b. Meetings
- c. Policies, plans and budget
- d. Accomplishment

Section 4. All barangay governments are hereby enjoined to create their respective drug abuse council to complement the functions and activities of the MADAC.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately.
