**AN ORDINANCE**

**RECLASSIFYING PARCELS OF LAND OWNED BY MR. BENIGNO CASTRO WITH TRANSFER CERTIFICATE OF TITLE NOS. T-040-201602677 AND T-040-2016028144 WITH TOTAL AREA OF THREE THOUSAND ONE HUNDRED EIGHTY TWO SQUARE METER (3,182 SQM) LOCATED AT BARANGAY STA ROSA 1, MARILAO, BULACAN FROM MINERAL ZONE TO INDUSTRIAL ZONE**

**Section 1. AUTHORITY TO RECLASSIFY.** Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of their utilization.

**Section 2. RECLASSIFICATION.** The parcels of land by Mr. Benigno Castro with Transfer Certificate of Title Nos. T-040-201602677 and T-040-2016028144 with total area of Three Thousand One Hundred Eighty Two Square Meter (3,182 Sqm) located at Barangay Sta Rosa 1, Marilao, Bulacan From Mineral Zone To Industrial Zone

**Section 3. MANNER OF UTILIZATION.** The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Marilao Bulacan and other applicable laws, rules and regulations.

**Section 5. EFFECTIVITY.** This ordinance shall take effect upon approval.


