MUNICIPAL ORDINANCE NO – 828

Introduced by Councilor Wilfredo D. Diaz and Councilor Ariel P. Amador and seconded by all members of the Sangguniang Bayan Present.

ORDINANCE

PROHIBITING THE MANUFACTURING, WAREHOUSING, SELLING, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS, PYROTECHNIC DEVICES AND OTHER SIMILAR EXPLOSIVES AND ESTABLISHING A FIRECRACKER DESIGNATED ZONE IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN AND PROVIDING PENALTY FOR THE VIOLATION THEREOF, AND FOR OTHER RELATED PURPOSES”.

SECTION 1. TITLE. An ordinance prohibiting the manufacturing, warehousing, selling, distribution, possession and use of firecrackers, pyrotechnic devices and other similar explosives and establishing a firecracker designated zone in the municipality of marilao, province of bulacan and providing penalty for the violation thereof, and for other related purposes”

SECTION 2. OBJECTIVES. The objective of this ordinance is to prohibit the manufacturing and warehousing of firecrackers and pyrotechnic devices, selling, distribution, possession and use of firecrackers and pyrotechnic devices and establishing a designating firecracker zone in order to promote peace and order and public safety to all inhabitants of this municipality.

SECTION 3. PROHIBITED TYPES OF FIRECRACKERS AND PYROTECHNIC DEVICES.

1. It is against the law for any person or business establishments to manufacture, warehousing, selling, distributing, possession and uses such firecrackers and pyrotechnic devices within the territorial jurisdiction of Municipality of Marilao.
2. Determination of prohibited firecrackers, pyrotechnics and other similar explosive shall be vested with Marilao CPNP.

SECTION 4. RESPONSIBLE AND SAFETY GUIDELINES.

1. The Local Chief Executive shall designate area for fireworks displays upon the recommendation of the BFP and the PNP. The centralized zone shall be in open space, far from residential, commercial and business center of the municipality.
2. It is allowed that the display will be done from 15th Day of December to 2nd Day January every year.
3. Using firecrackers and pyrotechnic devices during the date listed above and during a special occasion such as baptismal, birthday, weddings, anniversaries and traditional events shall secure a clearance from BPLO and shall notify the PNP and BFP.
4. Fireworks display shall be fired at a distance of one hundred (100) feet away from people.
5. The firework shall project upward.
6. Display may conduct under the supervision of trained person with adequate knowledge of handling fireworks.
7. The First Aid and fire protection equipment shall be visible at the site during the exhibition; and
8. The nearest BFP Station shall be notified of such exhibition.
9. The Local Government and PNP shall organize a long month campaign and dissemination of information against illegal use firecrackers and pyrotechnic devices.
10. Minors are also prohibited to handle and use of any firecrackers and pyrotechnic devices

SECTION 5. PROHIBITED ACTS WITHIN THE DESIGNATED AREA.

1. Testing of firecrackers and pyrotechnic devices shall be prohibited.
2. Smoking within fifteen (15) meters from display center shall not be allowed.
3. Exposed flames are prohibited
4. No firearms shall be allowed within the designated area and anything that could trigger fire should be kept away from this zone.
5. All confiscated firecrackers and pyrotechnic devices shall be destroyed under the supervision of the Local Chief Executive and PNP

SECTION 6. LICENSE AND PERMIT REQUIREMENT. Fireworks display is allowed in the municipality/barangay concerned through a permit specifying the date and time of fireworks display and specific area in which the display will be conducted. The permit shall be applied in the Municipal Government of Marilao through the Business Permit and Licensing Officer.

SECTION 7. PENALTY CLAUSE – Any person or establishment found to be using of firecrackers and pyrotechnic devices, selling, distribution, possession of firecrackers and pyrotechnic devices and other explosives shall be considered as to have violated this Ordinance and should penalized with fines as follow;

First Offense	One Thousand Pesos (P1,000.00)
Second Offense	Two Thousand Pesos (P2,000.00)
Third Offense	Three Thousand Pesos (P3,000.00)

Any person or business establishment found manufacturing or warehousing shall be punished by fine not less than Twenty Thousand Pesos (P20,000.00) or more than Thirty Thousand (P30,000.00) or imprisonment of not less than six (6) months (Section 2 of RA 7183). Aside from fine the business permit of the said establishment shall be cancelled and the firecrackers and pyrotechnic devices shall be confiscated.

SECTION 8. REPEALING CLAUSE. All previous local enactment, resolutions and other issuances inconsistent with this Ordinance are hereby repealed.

SECTION 9. SEPARABILITY CLAUSE. Should any provisions of this Ordinance shall be inconsistent with other existing laws; the other unaffected provisions of this ordinance shall remain in full force and effect.

SECTION 10. EFFECTIVITY. This ordinance shall take effect immediately after its approval and following its publication in a newspaper of general circulation.




