MUNICIPAL ORDINANCE NO. 791

Introduced by Councilor Wilfredo D. Diaz and unanimously seconded by all members of the Sangguniang Bayan present.

AN ORDINANCE

APPROVING THE ANNUAL BUDGET OF MUNICIPALITY OF MARILAO FOR FISCAL YEAR 2016 IN THE TOTAL AMOUNT OF FIVE HUNDRED EIGHTY MILLION THREE HUNDRED FIFTY FIVE THOUSAND ONE HUNDRED TWENTY TWO PESOS (P580,355,122.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE MUNICIPAL GOVERNMENT OF MARILAO FOR FISCAL YEAR 2016, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE, AND FURTHER AUTHORIZING THE MUNICIPAL MAYOR TO SIGN AND EXECUTE FOR IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, CONTRACT AGREEMENTS WITH THE WINNING BIDDERS OF PROJECTS COVERED THEREIN, SUBJECT TO EXISTING AUDITING LAWS, RULES AND REGULATIONS.

Be it ordained in Regular Session assembled:

Section 1. Annual Budget. – The Annual Budget of the Municipality of Marilao for Fiscal Year 2016 in the total amount of Five Hundred Eighty Million Three Hundred Fifty Five Thousand One Hundred Twenty Two Pesos (P580,355,122.00) covering the various expenditures for the operation of the Municipal Government for the year 2016 is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral parts of this Ordinance:

1. Budget of Expenditures and Sources of Financing;
2. Annual Investment Program;
3. Personnel Schedule by department/office/unit;
4. Others.



**REGULAR SESSION
MUNICIPAL ORDINANCE NO. 791**

Section 2.Sources of Funds. – The sources of funds for Budget Year 2016 shall be those provided in the respective Statements of Receipts for General Funds, Economic Enterprises-Market and Economic Enterprises – PambayangDalubhasaanngMarilao, hereto attached and made integral parts of this Ordinance.

Section 3.Use of Funds. – Funds for Budget Year 2016 shall be used in accordance with Programmed Appropriation and Obligation by Object, hereto attached and made integral part of this Ordinance.

Section 4.Use of Savings and Augmentation. – In accordance with Section 336 of Republic Act No. 7160, the Local Government Code of 1991, the Mayor and the Presiding Officer of the Sangguniang Bayan are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.


Section 5.Priority in the use of Personal Services Savings. – Priority shall be given to the personnel benefits of local employees in the use of Personal Services savings.

Section 6.Authority to the Municipal Mayor. – The Municipal Mayor is hereby authorized for and in behalf of the Municipal Government of Marilao, Bulacan, to execute and sign Contract Agreements with the winning bidders of the projects covered by the 2016 Annual Budget, subject to existing auditing laws, rules and procedures.

Section 7.Separability Clause. – If, for any reason, any section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

Section 8.Effectivity. The provisions of this Appropriations Ordinance shall take effect on January 1, 2016.
