PROVIDING FOR THE SUPPLEMENTAL BUDGET NO. 1 FOR THE CALENDAR YEAR 2016 AMOUNTING TO FORTY MILLION SIX HUNDRED FORTY SEVEN THOUSAND PESOS (P40,647,000.00), COVERING VARIOUS EXPENDITURES FOR THE OPERATION OF THE MUNICIPALITY OF MARILAO, AND FURTHER AUTHORIZING THE MUNICIPAL MAYOR TO SIGN AND EXECUTE FOR IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, CONTRACT AGREEMENTS WITH THE WINNING BIDDERS OF PROJECTS COVERED HEREIN, SUBJECT TO EXISTING AUDITING LAWS AND ISSUANCES.

Be it ordained by the Sangguniang Bayan, that:

Section 1. The amount of Forty Million Six Hundred Forty Seven Thousand Pesos (P40,647,000.00), or so much thereof as may be necessary, is hereby appropriated out of the unappropriated, available and/or existing funds in the Municipal Treasury, for Supplemental Budget No. 1for covering various expenditures for the operation of the Municipality of Marilao, Province of Bulacan, to wit:

REGULAR SESSION MUNICIPAL ORDINANCE NO. 797

Section 2.In the implementation of the infrastructure projects, the Municipal Engineer is hereby directed to put up an information billboard, including, among others, the amount of appropriation for the project, the target date of completion, the names of the Mayor, Vice Mayor, Members of the Sangguniang Bayan, concerned municipal officials and the officials of the barangay where the particular project is located.

Section 3.The Municipal Mayor is hereby authorized for and in behalf of the Municipal Government of Marilao, Bulacan, to execute and sign Contract Agreements with the winning bidders of the projects covered herein, subject to existing auditing laws and issuances.

Section 4.This Ordinance shall take effect after ten (10) days of its posting in a bulletin board at the entrance of the Municipal Hall and in at least two (2) other conspicuous places in the Municipality of Marilao.
