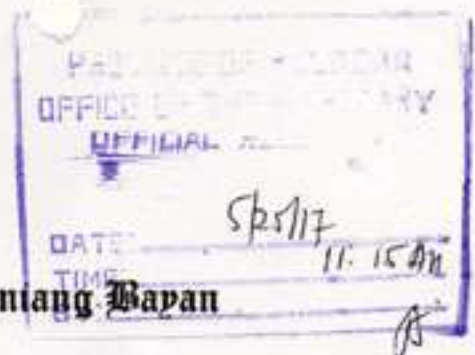

AN ORDINANCE

RECLASSIFYING PARCELS OF LAND OWNED BY EDMIRA VILLAMAR M/TO LAURO VILLAMAR AND DEVELOPED BY MERSANT POULTRY PROCESSING CORPORATION WITH TRANSFER CERTIFICATE OF TITLE NO. 040-2015022779 WITH TOTAL AREA OF NINE THOUSAND THREE HUNDRED NINETY EIGHT SQUARE METER (9,398 SQM) LOCATED AT BARANGAY STA ROSA 2, MARILAO, BULACAN FROM AGRICULTURAL TO INDUSTRIAL ZONE.

Section 1. AUTHORITY TO RECLASSIFY. Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of their utilization.

Section 2. RECLASSIFICATION. The parcels of land owned by Edmira Villamar m/to Lauro Villamar and developed by Mersant Poultry Processing Corporation with Transfer Certificate of Title No. 040-2015022779 with total area of Nine Thousand Three Hundred Ninety Eight Square Meter (9,398 sqm) located at barangay Sta Rosa 2, Marilao, Bulacan from agricultural to industrial zone

Section 3. MANNER OF UTILIZATION. The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Marilao Bulacan and other applicable laws, rules and regulations.

Section 4. CONVERSION. This ordinance shall not be construed as a conversion order which shall be issued by the Department of Agrarian Reform.

Section 5. EFFECTIVITY. This ordinance shall take effect upon approval.
