**AN ORDINANCE**

**RECLASSIFYING PARCELS OF LAND OWNED AND DEVELOPED BY CAMP RESOURCES PROPERTY HOLDINGS, INC. WITH TRANSFER CERTIFICATE OF TITLE NOS. T-391162 (M), T-39168(M), 040-2012012416, 040-2012012415, 040-2010000657, T-391160(M), T-209693(M), T-372174(M), T-391161(M), T-367077(M) AND T-447804(M) WITH A TOTAL AREA OF ONE THOUSAND ONE HUNDRED SIXTY FIVE SQUARE METER (1,165 SQ. M) LOCATED AT BARANGAY STA ROSA 1, MARILAO, BULACAN FROM AGRICULTURAL TO INDUSTRIAL ZONE.**

**Section 1. AUTHORITY TO RECLASSIFY.** Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of their utilization.

**Section 2. RECLASSIFICATION.** The Parcels land owned and developed by Camp Resources Property Holdings, Inc. with Transfer Certificate of Title Nos. T-391162 (M), T-39168(M), 040-2012012416, 040-2012012415, 040-2010000657, T-391160(M), T-209693(M), T-372174(M), T-391161(M), T-367077(M) and T-447804(M) with a total area of One Thousand One Hundred Sixty Five square meter (1,165 Sq. M) located at Barangay Sta Rosa 1, Marilao, Bulacan from Agricultural to Industrial Zone.

**MUNICIPAL ORDINANCE NO – 822**

**Section 3. MANNER OF UTILIZATION.** The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Marilao Bulacan and other applicable laws, rules and regulations.

**Section 4. CONVERSION.** This ordinance shall not be construed as a conversion order which shall be issued by the Department of Agrarian Reform.

**Section 5. EFFECTIVITY.** This ordinance shall take effect upon approval.




