WHEREAS, the Municipality of Marilao, Bulacan has properties which are unserviceable and the repair and rehabilitation costs therefore will amount to more than their book value;

WHEREAS, the municipality does not have the necessary funds to undertake the rehabilitation of these properties and the maintenance costs thereof;

WHEREAS, said properties are deteriorating and exposed to the elements, disposal through public bidding is deemed most advantageous to the government so as to generate maximum income from the sale thereof;

NOW, THEREFORE, it is hereby resolved as it is hereby;

RESOLVED, to favorably indorse the disposal of all unserviceable properties owned by the Municipal Government of Marilao, Bulacan;

RESOLVED, ALSO, that in the event of a failure of bidding, the Municipality may enter into negotiate sale;
