RESOLUTION

ADJUSTING THE ZONING CLASSIFICATION OF RESIDENTIAL/COMMERCIAL TO INDUSTRIAL ZONE COVERED BY TRANSFER CERTIFICATE OF TITLES NO. T-040-2014003572 AND CAD LOT NO. 3121 WITH TOTAL AREA OF EIGHT THOUSAND EIGHT HUNDRED EIGHTY SIX SQUARE METER (8,886 SQM) OWNED BY RONELO SAQUIAN LOCATED AT BARANGAY STA ROSA 1, MARILAO, BULACAN.

WHEREAS, Local Zoning Ordinance No. 619 S. 2007 requires the creation of Local Zoning Board of Adjustment and Appeals with the power to grant exception, variances or deviations from the provision of the Local Zoning Ordinance;

UNANIMOUSLY APPROVED, this 9th day of October, Two Thousand Seventeen.


