AUTHORIZING THE MUNICIPAL MAYOR HON. JUNAITO H. SANTIAGO FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH MARILAO ST. MICHAEL HOSPITAL, REPRESENTED BY ITS MEDICAL DIRECTOR DR. VENERANDA A. GEMARINO, FOR THE REFERRAL OF PHILHEALTH MATERNITY CARE PACKAGE AND NEWBORN CARE PACKAGE IN THE MUNICIPALITY OF MARILAO, BULACAN.

WHEREAS, presented to this Body for appropriate action, is the request of the Municipal Mayor, Honorable Juanito H. Santiago, for the adoption of a resolution authorizing the Municipal Mayor Hon. Junaito H. Santiago for and in behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum Of Agreement (MOA) with Marilao St. Michael Hospital, represented by its Medical Director Dr. Veneranda A. Gemarino, for the referral of Philhealth Maternity Care Package and Newborn care Package in the Municipality of Marilao, Bulacan subject to all the terms and conditions stipulated therein;

WHEREAS, Section 22 (a) (5) and (c) of the Implementing Rules and Regulations of the Local Government Code states that a Local Government Unit as a corporation shall have the power to enter into contracts provided that it is authorized by the Local Sanggunian;

WHEREAS, upon scrutiny on the Memorandum of Agreement (MOA), this Body finds the provisions of the Memorandum of Agreement (MOA) in order and within the bounds of law;

Gemarino, for the referral of Philhealth Maternity Care Package and Newborn care Package in the Municipality of Marilao, Bulacan;


