ADJUSTING THE ZONING CLASSIFICATION OF RESIDENTIAL TO INDUSTRIAL ZONE COVERED BY TRANSFER CERTIFICATE OF TITLES NOS. 040-2017008463, 040-2017008464 AND 040-2017008465 WITH TOTAL AREA OF TWO THOUSAND SIX HUNDRED TWENTY FOUR SQUARE METER (2,624 SQM) OWNED BY APOVIEW DEVELOPMENT CORPORATION LOCATED AT BARANGAY POBLACION 2, MARILAO, BULACAN.

WHEREAS, Local Zoning Ordinance No. 619 S. 2007 requires the creation of Local Zoning Board of Adjustment and Appeals with the power to grant exception, variances or deviations from the provision of the Local Zoning Ordinance;

WHEREAS, up to the present, the Local Zoning Board of Adjustment and Appeals has not been created and Local Zoning Reclassification/Adjustment are now being forwarded to Sangguniang Bayan for appropriate action;

WHEREAS, adjustment of zoning from Residential Zone to Industrial Zone is required before any permits can issued for their proposed construction;
