RESOLUTION

REQUESTING THE MUNICIPAL BUDGET OFFICE, THE MUNICIPAL ENGINEER'S OFFICE AND THE MUNICIPAL PLANNING AND DEVELOPMENT OFFICE AND OTHER MUNICIPAL GOVERNMENT OFFICES CONCERNED TO INFORM/CONSULT AND PROVIDE THE LOCAL CHIEF EXECUTIVE AND THE SANGGUNIANG BAYAN OF THE LOCAL GOVERNMENT UNIT OF MARILAO COPIES OF ALL PROGRAMS OF WORK AND PURCHASE REQUESTS BEING UNDERTAKEN BY THE MUNICIPAL GOVERNMENT.

WHEREAS, Section 524 (b) of the Local Government Code of 1991 state, that no infrastructure or community project within the territorial jurisdiction of any Local Government Unit shall be undertaken without informing the Local Chief Executive and the Sanggunian concerned;

WHEREAS, it is the policy of the state to require all national agencies and offices to conduct periodic consultations with appropriate Local Government Units, nongovernmental and people's organization and other concerned sectors of the community before any project or program is implemented in their respective jurisdiction, as stated in Section 2 (c) of the Local Government Code 1991;

WHEREAS, Section 25 (b) of the Local Government Code of 1991 state, that national agencies and offices with project implementation functions shall coordinate with one another and with the Local Government Units concerned in the discharge of this functions. They shall ensure the participation of Local Government Units both in the planning and implementation of said projects;

WHEREAS, Section 25 (d) of the Local Government Code of 1991 state, that national agencies and offices including government owned and or controlled corporations with field units or branches in the province, city or municipality shall furnish the Local Chief Executive concerned for his information and guidance, monthly reports including duly certified budgetary allocations and expenditures;

WHEREAS, the submission of all programs of work and purchase requests/ periodic accomplishment reports/list of various infrastructure and community projects implemented in this Municipality shall provide information and ready reference, and monitoring purposes of LGU-Marilao regarding the status of the different type of projects undertaken;

NOW THEREFORE, in view of the foregoing premises upon motion made and duly seconded,

BE IT RESOLVED AS IT IS HEREBY RESOLVED to request the Municipal Budget Office, the Municipal Engineer's Office and the Municipal Planning and Development Office and other municipal government offices concerned to inform/consult and provide the Local Chief Executive and the Sangguniang Bayan of Marilao copies of all programs of work and purchase requests being undertaken by the municipal government.

RESOLVED FINALLY, that copies of this Resolution be furnished the Municipal Budget Office, the Municipal Engineer's Office and the Municipal Planning and Development Office and other municipal government offices concerned; Mayor Juanito H. Santiago and other municipal government offices concerned for their information and guidance.
