FOR PARTNERSHIP AND ASSISTANCE IN DISASTER AND EMERGENCY RESPONSE.

WHEREAS, presented to this Body for appropriate action, is the request of the Municipal Mayor, Honorable Juanito H. Santiago, for the adoption of a resolution authorizing Him to Enter into a Memorandum of Agreement (MOA) with the 2 Air Reserve Wing, represented by its Wing Commander B/Gen. Artemio A.
