AUTHORIZING THE MUNICIPAL MAYOR, HON. JUANITO H. SANTIAGO, TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF TRADE AND INDUSTRY (DTI), RELATIVE TO THE ESTABLISHMENT OF A NEGOSYO CENTER IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.

WHEREAS, presented to this Body for appropriate action, is the request of the Municipal Mayor, Honorable Juanito H. Santiago, for the adoption of a resolution authorizing the Municipal Mayor Hon. Juanito H. Santiago, to enter into and sign, for and in behalf of the Municipality of Marilao, the Memorandum Of Agreement (MOA) with the Department of Trade and Industry (DTI), relative to the establishment of a Negosyo Center in the Municipality of Marilao, Province of Bulacan;

WHEREAS, Section 22 (a) (5) and (c) of the Implementing Rules and Regulations of the Local Government Code states that a Local Government Unit as a corporation shall have the power to enter into contracts provided that it is authorized by the Local Sanggunian;

WHEREAS, upon scrutiny on the Memorandum of Agreement (MOA), this Body finds the provisions of the Memorandum of Agreement (MOA) in order and within the bounds of law;

WHEREAS, this program requires no financial counterpart from the Municipal Government except for the designation of a focal person for this program who will ensure the implementation of the program in accordance with the action plan of the program;


