AUTHORIZING THE MUNICIPAL MAYOR HON. JUNAITO H. SANTIAGO FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH MARILAO ST. MICHAEL HOSPITAL, REPRESENTED BY ITS MEDICAL DIRECTOR DR. VENERANDA A. GEMARINO, FOR THE REFERRAL OF DIAGNOSTIC SERVICES (CBC, CHEST X-RAY, FECALYSIS, AND LIPID PROFILE) IN THE MUNICIPALITY OF MARILAO BULACAN.

WHEREAS, presented to this Body for appropriate action, is the request of the Municipal Mayor, Honorable Juanito H. Santiago, for the adoption of a resolution authorizing the Municipal Mayor Hon. Junaito H. Santiago for and in behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum Of Agreement (MOA) with Marilao St. Michael Hospital, represented by its Medical Director Dr. Veneranda A. Gemarino, for the referral of Diagnostic Services (CBC, Chest X-Ray, Fecalalysis, and Lipid Profile) in the Municipality of Marilao Bulacan;

WHEREAS, Section 22 (a) (5) and (c) of the Implementing Rules and Regulations of the Local Government Code states that a Local Government Unit as a corporation shall have the power to enter into contracts provided that it is authorized by the Local Sanggunian;

Gemarino, for the referral of Diagnostic Services (CBC, Chest X-Ray, Fecalalysis, and Lipid Profile) in the Municipality of Marilao Bulacan;




