GRANTING AUTHORITY TO THE MUNICIPAL GOVERNMENT THROUGH ITS MUNICIPAL MAYOR, HONORABLE JUANITO H. SANTIAGO, AS ITS DULY REPRESENTATIVE, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERTAKING (MOU) WITH MANILA ELECTRIC COMPANY (MERALCO) AS REPRESENTED BY MR. ALFREDO S. PANLILIO, SENIOR VICE PRESIDENT AND HEAD OF CUSTOMER RETAIL SERVICES AND CORPORATE COMMUNICATIONS, AND MR. RONNIE L. APEROCHO, SENIOR VICE PRESIDENT AND HEAD OF NETWORKS, FOR THE ESTABLISHMENT OF "MERALCO-MARILAO LOCAL GOVERNMENT UNIT ENERGIZING PARTNERSHIP".
