**RESOLUTION**

**AUTHORIZING THE MUNICIPAL MAYOR, HON. JUANITO H. SANTIAGO, REPRESENTING THE MUNICIPAL GOVERNMENT OF MARILAO TO ENTER INTO AND SIGN MEMORANDA OF AGREEMENT (MOA) WITH THE PRIVATE SCHOOLS IN MARILAO IN COMPLIANCE WITH THE REQUIREMENT OF THE DEPARTMENT OF EDUCATION'S (DepEd) K TO 12 ACCREDITATION.**

**WHEREAS**, the Municipal Government of Marilao (MGM) recognizes the indispensable contribution of private schools in the delivery of basic services to the community and as a partner in providing education to the youth;

**WHEREAS**, among the immediate concerns of the education sector is the impending setback of the implementation of the K-12 program in 2016;

**WHEREAS**, the MGM acknowledges that the existing public schools may not be able to accommodate all students during the implementation of DepEd's K-12 Program and supports the efforts of private schools to be a partner by offering senior high school (SHS);

**WHEREAS**, one of the requirements for accreditation is forging an agreement with the local government unit that it is willing to be a partner in various aspects of the program specifically in immersion/practicum training and research; and several schools have appealed to the Honorable Mayor Juanito H. Santiago relative to this requirement;

**WHEREAS**, the MGM and this Council believe that the accreditation of private high schools will address impending setbacks and interpose no objection to the aforementioned appeal subject to conditions to be stipulated in the agreement;


