RESOLUTION

AUTHORIZING THE MUNICIPAL MAYOR HONORABLE JUANITO H. SANTIAGO, REPRESENTING THE MUNICIPAL GOVERNMENT OF MARILAO, TO ENTER INTO AND SIGN A CONTRACT OF LEASE WITH MARIA ARMINA E. SANGALANG, OWNER OF A PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. T-312374 (M), TO BE USED AS A SITE FOR MUNICIPAL MOTOR POOL AND OTHER SIMILAR PURPOSES IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.

WHEREAS, On November 10, 2017, the Office of the Secretary to the Sangguniang Bayan received an endorsement letter from the Office of the Mayor, requesting a Sangguniang Bayan resolution to authorize the Municipal Mayor Hon. Juanito H. Santiago, representing the Municipal Government of Marilao, to enter into and sign a contract of lease with Maria Armina E. Sangalang, owner of a parcel of land covered by Transfer Certificate of Title No. T-312374 (M), to be used as a site for municipal motor pool and other similar purposes in the Municipality of Marilao, Province of Bulacan;

WHEREAS, the agreement will provide this Municipality a site for municipal motor pool and other similar purposes;

WHEREAS, the same is in conformity with standard government comity in delivering basic services to the general public;




