**WHEREAS**, the Bisitang Matanda in Poblacion I, Marilao, Bulacan was constructed in 1868 under the administration of Padre Vicente de Talavera, since then, it became the seat of Roman Catholicism in Marilao being the First Roman Catholic Church built in the area;

**WHEREAS**, Article III Section 5(f) Republic Act No. 10066, also known as the "National Cultural Heritage Act of 2009", stated that Structures dating at least fifty (50) years old shall be considered an important cultural property;

**WHEREAS**, the Bisitang Matanda with its open work and simple facade, was designed during those times to promote the spread of Roman Catholicism in Marilao;

**WHEREAS**, the declaration of the Bisitang Matanda in Poblacion I, Marilao, Bulacan as a Cultural Heritage shall preserve, conserve and protect the property from modification and demolition;

**NOW THEREFORE**, be it **RESOLVED**, as it hereby **RESOLVES**, to pass a Resolution supporting for the declaration to be a Cultural Heritage the Bisitang Matanda located in Poblacion I, Marilao, Bulacan.


