SANTIAGO, TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH REGION III (DOH-RO3) REPRESENTED BY ITS REGIONAL DIRECTOR LEONITA P. GORGOLON FOR THE IMPLEMENTATION OF ICLINICSYS AS AN ELECTRONIC MEDICAL RECORD AND HEALTH INFORMATION SYSTEM IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, presented to this Body for appropriate action, is the request of the Municipal Mayor, Honorable Juanito H. Santiago, for the adoption of a resolution authorizing the Municipal Mayor Hon. Juanito H. Santiago, to enter into and sign, for and in behalf of the Municipality of Marilao, the Memorandum Of Agreement (MOA) with the Department of Health Region III (DOH-RO3) represented by its Regional Director Leonita P. 
