ZARATE, RELATIVE TO THE IMPLEMENTATION OF HOUSEKEEPING TRAINING COURSE TO FIFTY (50) BENEFICIARIES IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.


