### EXECUTIVE ORDER NO. JS2026 - 22

#### AN ORDER MANDATING THE REORGANIZATION OF THE “ECOLOGICAL SOLID WASTE MANAGEMENT BOARD (ESWMB)” OF THE MUNICIPAL GOVERNMENT OF MARILAO, PROVINCE OF BULACAN

**WHEREAS**, Section 12 of Republic Act No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000, mandates that every city or municipality shall form a City or Municipal Waste Management Board responsible for the preparation, submission, and implementation of solid waste management plans within their respective jurisdictions;

**WHEREAS**, it is necessary to reorganize the existing Ecological Solid Waste Management Board (ESWMB) to consider the changes in the composition of some of its members;

**NOW, THEREFORE, I, ATTY. JEMINA M. SY**, Municipal Mayor of Marilao, Province of Bulacan, by virtue of the powers vested in me by law, do hereby order:

#### SECTION 1. REORGANIZATION OF THE “ECOLOGICAL SOLID WASTE MANAGEMENT BOARD (ESWMB)”

### (2) Duties and Responsibilities

The Technical Working Group shall assist the Board in planning, drafting, and implementing plans, programs, and activities in line with RA 9003. It may also create sub-committees among its members to facilitate its functions.

## SECTION 2. DUTIES AND RESPONSIBILITIES OF THE ESWMB

The ESWMB shall have the following duties and responsibilities:

- a. Develop the Municipal Solid Waste Management Plan to ensure long-term solid waste management and integrate various barangay-level strategies through sectoral consultations.
- b. Initiate measures to ensure the effective implementation of waste management programs in every barangay.
- c. Monitor the implementation of the Municipal Solid Waste Management Plan in partnership with public and private sectors, as well as NGOs.
- d. Conduct regular meetings for planning and coordination to ensure efficient plan execution at the barangay level.
- e. Evaluate the implementation of the Municipal Solid Waste Management Plan across the municipality.
- f. Review the Plan every two (2) years, or as needed, to ensure relevance, sustainability, and alignment with local and international waste management developments.
- g. Establish specific mechanisms and guidelines for implementing the Solid Waste Management Plan.
- h. Recommend proposals related to franchise agreements or build-operate-transfer (BOT) contracts, in accordance with RA 6957, to authorize institutions in waste collection, storage, processing, recycling, and disposal.
- i. Provide necessary logistical and operational support to the municipality as provided under Section 17(f) of the Local Government Code.
- j. Recommend policies for pollution control and protection of natural ecosystems.
- k. Perform other related tasks as may be directed by the Municipal Mayor.

## SECTION 3. MEETINGS

The ESWMB shall convene quarterly, based on the date, time, and venue stated in the meeting notice. A quorum must be established before the meeting begins.

## SECTION 4. FILLING OF VACANCIES

Any vacancy in the membership of the ESWMB shall be automatically filled by a successor appointed or designated by the Municipal Mayor, whose name shall be deemed included under Section 1 of this Executive Order.

### SECTION 7. EFFECTIVITY CLAUSE

This Executive Order shall take effect immediately.
