Lutao, submitted to this August Body a First Endorsement Letter entitled "A resolution approving and adopting the Local Health Board Resolution No. 2023-012 entitled, 'A resolution adopting Barangay Health Worker Policy in the Municipality of Marilao' for its appropriate actions";

WHEREAS, the contribution of the BHWs in the local health system has long been recognized, hence RA No. 7883 or the BHWs' Benefits and Incentives Act of 1995 and its Implementing Rules and Regulations (IRR) were issued to protect the interest of the BHWs and provide them with support for their continual development, there have been reports of discontinuing their services by some LGU officials;

WHEREAS, the Local Health Board through the municipal health office shall formulate and implement policies, programs or specific strategies that shall afford protection to the BHWs including but not limited to the criteria/process for discontinuation of services and in cases of complaints and grievances;

NOW, THEREFORE on motion of Honorable Allane T. Sayo, duly seconded by Hon. Ariel P. Amador and upon unanimous vote.

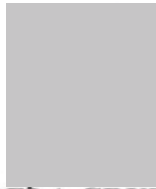
