### EXECUTIVE ORDER NO. JS2026 - 17

#### AN ORDER ESTABLISHING AND SUSTAINING THE MIGRANT ADVISORY AND INFORMATION NETWORK (MAIN) IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN

**WHEREAS**, R.A. No. 9208 enacted in 2003, otherwise known as “Anti-Trafficking in Persons Act” declared that the State values the dignity of every human person and guarantees the respect of individual rights;

**WHEREAS**, in the same law, it was also declared that the State recognizes the equal rights and inherent human dignity of women and men as enshrined in the United Nations Universal Declaration on Human Rights, United Nations Convention on the Rights of the Child, United Nations Convention on the Protection of Migrant Workers and their Families, United Nations Convention Against Transnational Organized Crime Including its Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children and all other relevant and universally accepted human rights instruments and other international conventions;

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2005-26 dated March 14, 2005 on the strict implementation of Republic Act No. 9208 to all levels of local governments, DILG Field Offices, and other concerned offices;

**WHEREAS**, Memorandum Circular No. 2006- 172 dated December 12, 2006 was also issued to further strengthen LGU’s efforts against human trafficking;

**WHEREAS**, the Circular mandates the LGUs, among others, to sustain the Migrant Advisory and Information Network (MAIN) Desk in municipalities or provinces in coordination with DILG, Philippine Information Agency (PIA), Commission on Filipinos Overseas (CFO), NGOs and other concerned agencies.

**NOW, THEREFORE, I, ATTY. JEMINA M. SY**, Municipal Mayor of Marilao, Bulacan, by virtue of the powers vested in me by pertinent laws, do hereby order:

**SECTION 1. ORGANIZATION.** The Migrant Advisory and Information Network Desk (MAIN) is hereby lodged with the Municipal Public Employment Service Office (MPESO).

**SECTION 2. FUNCTIONS.** To ensure an integrated and concerted effort, the MAIN Desk, in addition to its defined functions of generating, maintaining, and providing information related to human trafficking (based on DILG MC No. 2005-26), in coordination with concerned local offices, undertake the following related activities:

1. Preparation of referrals of Mail Order Bride cases;
2. Documentation of cases of trafficking and illegal recruitment;
3. Establishment and partnership with the Municipal Public Employment Service Office (MPESO) in generating information of illegal recruiter, in cooperation with the Municipal Social Welfare and Development Office, on the provision of data on victims/affected family for livelihood assistance;
4. Interconnection with concerned agencies and non-government organizations;

5. Development and dissemination of IEC materials on cases of trafficked persons /children, and;
6. Maintaining partnership with the local media on campaign against human trafficking.

**SECTION 3. EFFECTIVITY.** This Order shall take effect immediately upon approval and shall supersede all previous orders inconsistent thereto.
