### EXECUTIVE ORDER NO. JS2026 - 21

#### REORGANIZING THE MUNICIPAL TRICYCLE FRANCHISING BOARD (MTFRB) OF THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN

**WHEREAS**, pursuant to Section 444 (B)(2)(iii) of the Local Government Code of 1991, the Municipal Mayor has the authority to issue Executive Orders for the efficient and effective management of local governance, for the welfare of the people, and for the proper implementation of laws within her jurisdiction;

**WHEREAS**, the Sangguniang Bayan of Marilao enacted Municipal Ordinance No. 664 on December 10, 2008, also known as the Revised Tricycle Code of the Municipality of Marilao, as amended by Municipal Ordinance No. 702 dated August 16, 2011;

**WHEREAS**, the technical expertise related to the tricycle-for-hire industry must be considered to ensure effective regulation and enforcement;

**WHEREAS**, the creation and establishment of the Municipal Tricycle Franchising Board (MTFRB) is necessary to ensure the continuous implementation of existing laws governing tricycle operations;

**WHEREAS**, there is a need to reorganize the Municipal Tricycle Franchising Board (MTFRB) to align with the current term of local governance;

**NOW, THEREFORE**, I, **ATTY. JEMINA M. SY**, Municipal Mayor of Marilao, Province of Bulacan, by virtue of the powers vested in me by law, do hereby order:

#### SECTION 1. REORGANIZATION OF THE MUNICIPAL TRICYCLE FRANCHISING BOARD (MTFRB).

By virtue of this Order, the Municipal Tricycle Franchising Board (MTFRB) of the Municipality of Marilao, Province of Bulacan, is hereby reorganized and shall be composed of the following:

### **SECTION 2. DUTIES AND RESPONSIBILITIES OF THE MTFRB.**

The Municipal Tricycle Franchising Board (MTFRB) shall have the following duties and responsibilities:

- a. Issue, suspend, revoke, cancel, or withdraw franchises in accordance with the provisions of existing laws, ordinances, rules, and regulations;
- b. Exercise direct control and supervision over all tricycle operators' and drivers' associations within the municipality, and impose disciplinary measures against any association, member, or officer that refuses or fails to comply with this Order, after proper hearings have been conducted;
- c. Coordinate with adjacent municipalities and cities on matters relating to the monitoring and regulation of tricycle-for-hire operations;
- d. Review, approve, and revoke recommended decisions of the Tricycle Regulatory Unit (TRU);
- e. Recommend to the Sangguniang Bayan appropriate legislative measures concerning rental management, issuance and cancellation of franchises or operating permits, fare rates, zones, fees, other charges, and other traffic-related regulatory measures;
- f. Recommend to concerned national government agencies the prosecution, penalization, suspension, cancellation, or revocation of franchises, permits, and licenses of erring tricycle operators and drivers;
- g. Promulgate policies and regulations for the proper implementation of this Executive Order, which shall remain in effect unless repealed or amended by the Sangguniang Bayan; and
- h. Perform such other related functions as may be necessary or as may be directed by the Municipal Mayor.

**SECTION 3. FILLING OF VACANCIES.** Any vacancy in the membership of the MTFRB shall be automatically filled by a replacement appointed or designated by the Municipal Mayor, who shall serve for the remainder of the current term. The name of the replacement shall be deemed ipso facto included in Section 1 of this Executive Order.

**SECTION 4. SEPARABILITY CLAUSE.** If, for any reason, any part or provision of this Executive Order is declared unconstitutional or invalid, the remaining provisions unaffected thereby shall continue to be in full force and effect.

**SECTION 5. REPEALING CLAUSE.** All other executive orders, rules, regulations, or parts thereof inconsistent with this Executive Order are hereby repealed or amended accordingly.

**SECTION 6. EFFECTIVITY.** This Executive Order shall take effect immediately.
