### EXECUTIVE ORDER NO. JS2026 - 26

#### REORGANIZATION OF THE LOCAL HEALTH BOARD (LHB) IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN

**WHEREAS**, Section 102 of the Local Government Code provides that a local health board shall be established in every province, city, or municipality;

**WHEREAS**, there is a need to reorganize the Local Health Board for the current term;

**NOW, THEREFORE**, I, **ATTY. JEMINA M. SY**, Municipal Mayor of Marilao, Province of Bulacan, by virtue of the powers vested in me by law, do hereby order:

#### **SECTION 1. REORGANIZATION OF THE LOCAL HEALTH BOARD.**

Through this Executive Order, the Local Health Board (LHB, for brevity) in the Municipal Government of Marilao is hereby reorganized, to be composed of the following:

### SECTION 2. DUTIES AND RESPONSIBILITIES OF THE LHB.

The LHB shall perform the following duties and responsibilities:

- a. Propose to the Sangguniang Bayan, in accordance with the standards set by the Department of Health (DOH), the annual budget allocation for the operation and maintenance of health facilities and services within the municipality;
- b. Serve as an Advisory Committee to the Sangguniang Bayan on local appropriations for public purposes; and
- c. In accordance with the technical and administrative standards of the Department of Health (DOH), create committees to advise the local agencies of the health board on matters such as, but not limited to, personnel selection and promotion, bidding and awards, grievances and complaints, personnel discipline, budget review, operations review, and similar functions.

### **SECTION 3. TERM OF OFFICE.**

The term of office of the LHB members shall be until noon of June 30, 2028. However, members may continue to act in their capacity until their successors shall have been appointed.

### **SECTION 4. MEETINGS.**

The LHB shall meet monthly on the date, time, and place indicated in the meeting notice. A quorum must be ensured before the meeting may commence.

### **SECTION 5. FUNDING.**

The funds for the LHB shall be sourced from the budget of the Office of the Municipal Mayor and shall be included in the annual budget of the said office.

### **SECTION 6. FILLING OF VACANCIES.**

Any vacancy in the membership of the LHB shall automatically be filled by the successor chosen or appointed by the Municipal Mayor, who shall serve the unexpired term. The name of the successor shall *ipso facto* be included in Section 1 of this Executive Order.

### **SECTION 7. SEPARABILITY CLAUSE.**

If, for any reason, any part or provision of this Executive Order is found to be unconstitutional, the other parts or provisions not affected thereby shall remain valid and effective.

### **SECTION 8. REPEALING AND AMENDING CLAUSE.**

All other orders, rules, regulations, or parts thereof inconsistent with this Executive Order are hereby repealed or amended accordingly.

### **SECTION 9. EFFECTIVITY.**

This Executive Order shall take effect immediately.
