### EXECUTIVE ORDER NO. JS2026-31

#### AN ORDER MANDATING THE REORGANIZATION OF THE “LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC)” IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN

**WHEREAS**, Republic Act No. 9262 mandates that government shall give the highest priority to the implementation of measures and development of programs that promote human dignity, protect individuals from violence and exploitation, and eradicate human trafficking to ensure the rehabilitation and reintegration of its victims;

**WHEREAS**, Republic Act No. 9262 further emphasizes the commitment of the State to safeguard the dignity of women and children while guaranteeing full respect for their human rights and protecting them from violence and threats to their personal safety and security;

**WHEREAS**, Republic Act No. 9710, otherwise known as the Magna Carta of Women, is a comprehensive women’s human rights law that seeks to eliminate discrimination against women by recognizing, protecting, fulfilling, and promoting the rights of Filipino women, particularly those in marginalized sectors of society;

**WHEREAS**, there is a need to reorganize the composition of the “Local Committee on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC)” for the current term;

**NOW, THEREFORE, I, ATTY. JEMINA M. SY**, Municipal Mayor of Marilao, Province of Bulacan, by virtue of the powers vested in me by law, do hereby order:

#### SECTION 1. REORGANIZATION OF THE “LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC).”

Through this Order, the Local Committee on Anti-Trafficking and Violence Against Women and their Children (hereinafter referred to as LCAT-VAWC) of the Municipal Government of Marilao is hereby reorganized, to be composed of the following:

### SECTION 2. DUTIES AND RESPONSIBILITIES.

The LCAT-VAWC shall perform the following duties and responsibilities:

- a. Formulate policies and programs to protect women and children victims of trafficking and violence, as well as assist in the drafting of local ordinances and resolutions;
- b. Establish and implement systems of investigation and rescue to ensure effective and efficient coordination in assisting VAWC victims;
- c. Conduct widespread information dissemination, education, and advocacy campaigns against human trafficking and VAWC;
- d. Monitor and enforce strict compliance with RA 9208, RA 9262, and other related laws for the protection of women and children, as well as with the national plan of action for LCAT and VAWC; and
- e. Undertake other related activities as may be deemed necessary or as directed by the Chairperson.

The Secretariat shall be responsible for documenting proceedings and meetings, as well as preparing reports and other necessary documents of the LCAT-VAWC and its related agencies.

### SECTION 3. MEETINGS.

The LCAT-VAWC shall convene every quarter, at such date, time, and venue as may be specified in the meeting notice. A quorum must be ensured before the meeting begins.

### SECTION 4. VACANCIES.

Any vacancy in the membership of the LCAT-VAWC shall automatically be filled by a successor appointed or designated by the Municipal Mayor, who shall serve for the unexpired term. The name of the successor shall be *ipso facto* included in Section 1 of this Executive Order.

### SECTION 5. REPEALING CLAUSE.

All other orders, rules, regulations, or parts thereof inconsistent with this Executive Order are hereby repealed or amended accordingly.

### SECTION 6. EFFECTIVITY.

This Executive Order shall take effect immediately.
