EXECUTIVE ORDER NO. JS2026-32

REORGANIZING THE TOURISM COUNCIL OF THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN

WHEREAS, the Department of Interior and Local Government Memorandum Circular No. 162-95, dated October 2, 1995 enjoins all Local Government Units to create a Tourism Council;

WHEREAS, the State declares tourism as an indispensable element of the national economy and an industry of national interest and importance, which must be harnessed as an engine of socio-economic growth and cultural affirmation to generate investment, foreign exchange and employment, and to continue to mold and enhance the sense of national pride of all Filipinos;

WHEREAS, the Marilao Tourism Council has served as the coordinative body with government and private sector members that were tasked to promote local tourism development and recommend policies and programs related to the tourism sector;

WHEREAS, in order to enable the Municipal Government of Marilao to effectively carry out and implement its tourism projects, there is a need to reorganize, streamline and define a more effective, efficient and relevant Tourism Council in Marilao that is reflective of the new and diverse players in the local tourism industry and sustain the gains achieved by the previous tourism councils;

NOW, THEREFORE, I, ATTY. JEMINA M. SY, Municipal Mayor of Marilao, Bulacan, by virtue of the powers vested in me by pertinent laws, do hereby ORDER:

SECTION 1. COMPOSITION. There is hereby a reorganization of the Marilao Tourism Council, hereinafter referred to as the MTC, to be composed of the following:

SECTION 2. DUTIES AND FUNCTIONS.

The Marilao Tourism Council shall perform the following duties and functions:

1. Provide policy advice and direction to guide the development of plans, programs and activities of the municipality relative to the promotion, advancement and preservation of local culture and arts;
2. Ensure that the tourism potential of the municipality is utilized to the advantage of business, local industry and economy;
3. Ensure that local talents, artistry and ingenuity are encourage, developed, supported and recognized; and

4. Perform other functions as may be necessary to ensure that local culture and arts are given due importance.

SECTION 3. FILLING IN OF VACANCY.

Any vacancy in the membership shall automatically be filled in by the successor or duly appointed by Municipal Mayor, and who shall serve only for the unexpired term. The name of the successor will be *ipso facto* included in Section 1 of this Order.

SECTION 4. REPEALING CLAUSE. All other orders, rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This Order shall take effect immediately.
