EXECUTIVE ORDER NO. JS2026-33

REORGANIZING THE MARILAO CULTURE AND THE ARTS COUNCIL IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN

WHEREAS, Section 16 of the Local Government Code of 1991 provides that Local Government Unit shall ensure and support the preservation and enrichment of Filipino culture;

WHEREAS, DILG Memorandum Circular No. 2017-133 enjoins all provinces, cities and municipalities for the establishment of a Local Culture and Arts Council to implement related projects and/or strengthen existing one thereafter;

WHEREAS, the Council will plan for the promotion of the Filipino culture, instill nationhood, raise the level of consciousness of the people on cultural unity, values and conservation of historical and cultural heritage;

NOW, THEREFORE, I, ATTY. JEMINA M. SY, Municipal Mayor of Marilao, Bulacan, by virtue of the powers vested in me by pertinent laws, do hereby ORDER:

SECTION 1. COMPOSITION. There is hereby a reorganization of the Local Culture and the Arts Council, hereinafter referred to as the LCAC, to be composed of the following:

SECTION 2. DUTIES AND FUNCTIONS. The Marilao Culture and Arts Council shall perform the following duties and functions:


- a. Prepare an annual plan on culture, arts, and cultural heritage consonant with the Philippine Development Plan for Culture and the Arts, to be integrated in the local development plan and considered in the annual appropriation ordinances;
- b. Formulate programs and recommendations to develop and sustain local cultural and artistic talents, cultural industries, traditional and contemporary arts and crafts, and their processes;
- c. Coordinate with the appropriate affiliated cultural agencies of the National Commission for Culture and the Arts (NCCA) for the conservation and monitoring of national cultural properties found in the LGU;
- d. Conduct cultural events such as cultural festivals, competition, lectures, seminars and symposia;
- e. Identify such other programs and activities for the promotion of local cultural heritage and arts;
- f. Ensure the protection, preservation, conservation and promotion of the local cultural and historical heritage;
- g. Declare and maintain Local Heritage Zones;
- h. Establish a Local Registry of Cultural Property;
- i. Acknowledge the importance of traditional folk artist as singular conduit between skills of the past and the future;
- j. Revitalize a community's artistic tradition thereby protecting a valuable fact of Philippine culture;
- k. Provide mechanisms for identification and assistance for qualified traditional folk artists to transfer their skills to the community; and,
- l. Create opportunities for popularizing their works locally.

SECTION 3. FILLING IN OF VACANCY. Any vacancy in the membership shall automatically be filled in by the successor or duly appointed by Municipal Mayor, and who shall serve only for the unexpired term. The name of the successor will be *ipso facto* included in Section 1 of this Order.

SECTION 4. REPEALING CLAUSE. All other orders, rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This Order shall take effect immediately.
