EXECUTIVE ORDER NO. JS2026-37

AN ORDER FOR THE REORGANIZATION OF THE PROJECT MONITORING COMMITTEE (PMC) IN THE MUNICIPAL GOVERNMENT OF MARILAO, PROVINCE OF BULACAN

WHEREAS, Department of the Interior and Local Government (DILG) Memorandum No. 175, series of 1988, mandates the creation of a Project Monitoring Committee in every province, city, and municipality;

WHEREAS, Executive Order No. 376, s. 1989, as amended by Executive Order No. 93, s. 1993, established the Regional Project Monitoring and Evaluation System (RPMES) to facilitate project implementation, resolve issues, monitor, and evaluate foreign-assisted, national, and local projects;

WHEREAS, the Project Monitoring Committee shall serve as the monitoring arm of the Municipal Development Council (MDC) and its scope of responsibility has been expanded to include monitoring, evaluation, and formulation of recommendations regarding the implementation of development plans and programs of the municipality, particularly projects under the Local Government Support Fund – Assistance to Municipalities;

NOW, THEREFORE, I, **ATTY. JEMINA M. SY**, Municipal Mayor of Marilao, Province of Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. REORGANIZATION OF THE PROJECT MONITORING COMMITTEE.

By virtue of this Order, the Project Monitoring Committee (PMC) in the Municipal Government of Marilao is hereby reorganized and shall be composed of the following:

SECTION 2. DUTIES AND RESPONSIBILITIES.

The PMC shall perform the following duties and responsibilities:

- a. Exercise the power and authority to oversee the registry of all programs and projects of the Municipal Government of Marilao, including their expenditures and sources of funds;
- b. Monitor, investigate, and report to the Office of the Municipal Mayor all anomalies and deficiencies in the implementation of municipal projects and programs;
- c. Provide recommendations on corrective actions and policies concerning the implementation of projects and programs in the municipality;
- d. Prepare monitoring programs including the list of projects and their implementation schedules;
- e. Provide information to the Municipal Mayor regarding projects being monitored by the PMC;
- f. Facilitate linkages within and outside the agency as necessary; and
- g. Perform other related tasks as may be required by circumstances or as directed by the Municipal Mayor.

SECTION 3. MEETINGS.

The PMC shall convene every quarter (once every three months) on the date, time, and place specified in the meeting notice. The presence of a quorum must be ensured before the meeting begins.

SECTION 4. VACANCIES.

Any vacancy shall be automatically filled by a successor appointed or designated by the Municipal Mayor, who shall serve the unexpired term. The name of the successor shall be *ipso facto* included in Section 1 of this Executive Order.

SECTION 5. REPEALING CLAUSE.

All other executive orders, rules, regulations, or portions thereof inconsistent with this Executive Order are hereby repealed or amended accordingly.

SECTION 6. EFFECTIVITY.

This Executive Order shall take effect immediately.
