WHEREAS, in Section 34 of the Local Government Code of 1991 (Republic Act No. 7160) supports the creation and operation of people's organizations (POs) and non-governmental organizations (NGOs) in the promotion of local autonomy;

WHEREAS, Susan R. Brito, Chairwoman of **HM Multipurpose Cooperative** has expressed intention to be accredited and eventually become partner in any local government undertaking;
