PURSUIT OF LOCAL AUTONOMY.**

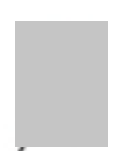

**WHEREAS**, Article 62, Rule XIII of the Implementing Rules and Regulations (IRR) of Local Government Code 1991 strengthens the aforementioned provision, emphasizing that NGOs and POs should be included in the planning and execution of local government projects and activities, participate in local special bodies, and assist in the delivery of public services;

**WHEREAS**, Civil Society Organization shall comply with all the requirements and criteria set forth in the DILG Memorandum Circular 2025-060, and their programs and projects should have a contribution to the Local Government Unit of Marilao;
