WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a letter of Endorsement entitled, "*A Resolution authorizing the Municipal Mayor, Atty. Jemina M. Sy, for and in behalf of the Municipal Government of Marilao, to enter into and sign application forms, contract, and other pertinent documents with the Manila Electric Company (MERALCO), for the implementation of Electrical Services and related Transactions in the Municipality of Marilao, Province of Bulacan.*" for appropriate action;

WHEREAS, under Section 22 (a) (5) and (c) of the Local Government Code states that a Local Government Unit, through its local chief executive may be entered into contracts provided that it is authorized by the Local Sanggunian;

WHEREAS, upon scrutiny on the application form, contract and other pertinent documents, this Body finds the provisions of the same in order and within the bounds of law;

WHEREAS, the same is in conformity with standard government comity in delivering basic services to the general public;
