**RESOLUTION DECLARING A STATE OF CALAMITY IN THE MUNICIPALITY OF
MARILAO, PROVINCE OF BULACAN, AND FOR OTHER PURPOSES.**

WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy presented to this August Body a transmittal attached herewith is the Resolution No. MDRRMC-06 Series of 2025 entitled: Resolution declaring a state of calamity in the Municipality of Marilao, Province of Bulacan due to Southwest Monsoon (Habagat), for its appropriate action;

WHEREAS, Typhoon Crising and Southwest Monsoon (Habagat) caused widespread devastation and damage to houses, infrastructure, properties, and agriculture, and resulted in the disruption of critical lifelines of Filipinos in areas affected by the said typhoon;

WHEREAS, the Typhoon Crising exacerbated by the high tide and enhance the monsoon rain;

WHEREAS, the declaration of State of Calamity will hasten the rescue, relief, and rehabilitation efforts of the government and the private sector, including any international humanitarian assistance; and

WHEREAS, this declaration will, among others, effectively control the prices of basic goods and commodities in the affected areas, and afford the National Government, as well as local government units (LGUs), ample latitude to utilize appropriate funds for the rescue. Recovery, relief, and rehabilitation of, and the continuation of basic services to, affected populations, in accordance in with law;

WHEREAS, the devastation and displacement on the lives and property brought about by typhoon "Crising" and Southwest Monsoon (Habagat) to the residents of this municipality, necessitate the adoption of contingency measures aimed at alleviating the miserable conditions of the municipal inhabitants;


WHEREAS, the declaration of a state of calamity in the municipality would pave the way for the release of calamity fund intended for such emergencies;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to declare a state of calamity in the Municipality of Marilao in the Province of Bulacan.


RESOLVED FURTHER, that copies of this resolution be sent to all concerned for their information, guidance and appropriate action.
