WHEREAS, the said Ambulance is a medically-equipped vehicle, including stretchers, oxygen tanks, defibrillators, and other devices necessary for emergency treatment, used to transport patients to treatment facilities, such as hospitals.

WHEREAS, Ambulances are designed to safely and efficiently transport patients, whether from the scene of an accident, a medical emergency, or between healthcare facilities;
