WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a **Letter of Endorsement entitled** *“A Resolution authorizing the Municipal Mayor, Honorable Atty. Sy, for and in behalf of the Municipal Government of Marilao, to enter into a Memorandum of Agreement (MOA) with the Department of Agriculture-Regional Field Office III, represented by its Regional Executive Director, Dr. Eduardo L. Lapuz, Jr., for the implementation of LEED-Sheep Module Project in the Municipality of Marilao, Province of Bulacan.”* for its appropriate action;

WHEREAS, Republic Act No. 8435 otherwise known as Agriculture and Fisheries Modernization Act of 1997 (AFMA), sets out the Government’s policies in the agriculture sector in attaining equitable distribution of opportunities, income, and wealth, expanding productivity and sustaining increase in production of goods and services thereby raising the quality of life of the people;

WHEREAS, the Department of Agriculture (DA) issued a Memorandum Order 41 Series of 2023 with its subject *“Amendment to Memorandum Order No.23 Series 2016, ‘Enterprise Development through the establishment of sustainable livestock and poultry Multiplier Farms’ incorporating herewith relevant implementing Rules and Guidelines for the Livestock Enterprise*

and Economic Development Program' also known as LEED Program" for the continuous implementation of the DA Memorandum Order No. 23 Series 2016 and to include and incorporate guidelines for the implementation of LEED Program;

WHEREAS, the objective of Multiplier Farms Project (MFP) is to establish breeding farms in strategic areas of the country, producing genetically superior breeder animals for distribution to qualified individuals or groups for livelihood and/ or enterprise development;

WHEREAS, the Municipality of Marilao that advocates goat/sheep/cattle production as an alternative meat to improve nutrition of the Marileno and promotes goat/sheep/cattle production as an additional source of income to farmers and communities in this Municipality;


NOW, THEREFORE, on motion of Hon. Juanito H. Santiago seconded by Hon. Maria Luisa I. Silvestre and upon unanimous vote;

BE IT RESOLVED, AS IT HEREBY RESOLVED, to pass "A Resolution authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and in behalf of the Municipal Government of Marilao, to enter into a Memorandum of Agreement (MOA) with the Department of Agriculture-Regional Field Office III, represented by its Regional Executive Director, Dr. Eduardo L.
