EXECUTIVE ORDER NO. JS2026-57

REORGANIZING THE LOCAL YOUTH DEVELOPMENT COUNCIL (LYDC) OF THE MUNICIPAL GOVERNMENT OF MARILAO, DEFINING ITS FUNCTIONS AND PURPOSES

WHEREAS, Article 2, Section 13 of the 1987 Philippine Constitution provides that "the State recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being.";

WHEREAS, Section 2(b) of Republic Act No. 8044 otherwise known as the "Youth in Nation Building Act" provides that "Youth" is the critical period in a person's growth and development from the onset of adolescence towards the peak of mature, self-reliant and responsible adulthood comprising the considerable sector of the population from the age of fifteen (15) to thirty (30) years;

WHEREAS, Chapter III, Section 23 of Republic Act (R.A.) No. 10742 otherwise known as the "Sangguniang Kabataan Reform Act of 2015" and the Department of Interior and Local Government (DILG) Memorandum Circular No. 2017-36 mandates the creation of a Local Youth Development Office (LYDO) and the organization of a Local Youth Development Council (LYDC) in every province, city, and municipality to ensure the wide and multi-sectoral youth participation in local governance;

WHEREAS, there is an immediate need to address the primary concerns of the youth in Marilao, Bulacan;

NOW, THEREFORE, I, ATTY. JEMINA M. SY, Municipal Mayor of Marilao, Bulacan, by virtue of the powers vested in me by law, do hereby ORDER:

SECTION 1. REORGANIZATION OF THE MARILAO LOCAL YOUTH DEVELOPMENT COUNCIL. There is hereby reorganized a Local Youth Development Council (LYDC) in the Municipality of Marilao, Province of Bulacan.

SECTION 2. COMPOSITION. The LYDC shall be headed by the Sangguniang Kabataan (SK) Pederasyon President and shall be composed of at least ten (10) but not more than twenty-one (21) members including the two (2) core members of the SK and at least eight (8) but not more than nineteen (19) other representatives from established youth organizations or youth-serving organizations duly recognized by the SK Pederasyon. The representatives-members shall serve for three (3) years. As much as possible, the youth organization or youth-serving organizations shall include, but not limited to, those whose core advocacies involve peace, out-of-school youth, health, disaster, LGBTQ, Islam, faith, environment, community, PWD, and academe.

SECTION 3. QUALIFICATION OF THE MEMBERS. A member of the LYDC must be a citizen of the Philippines, a resident of Marilao, Bulacan for not less than one (1) year immediately preceding the day of their election to the LYDC, at least fifteen (15) years but not more than thirty (30) years on the day of their election to the council, able to read and write Filipino, English, or the local dialect, and must not have been convicted by final judgment of any crime involving moral turpitude.

SECTION 4. FUNCTIONS. The LYDC shall have the following duties and functions:

1. Serve as the core of the advocacy on youth participation in nation-building and youth empowerment;
2. Finalize the three (3) year Local Youth Development Plan (LYDP) that is anchored in the Philippine Youth Development Plan and the development plans of the local government units. The LYDP shall be initially drafted by the SK Pederasyon and shall be finalized by the LYDC. This shall be submitted to the Local Chief Executive for inclusion in the Local Development Plan and subsequently endorsed to the Sangguniang Bayan. These plans shall give priority to the programs, projects, and activities that will promote and ensure the meaningful youth participation in nation-building, sustainable youth development and empowerment, equitable access to quality education, environmental protection, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, capability building, and sports development.
3. Monitor and evaluate the implementation of the Local Youth Development Plan; and
4. Perform such other functions as may be prescribed by law or ordinance.

SECTION 5. SUPERVISION. Supervision over the Local Youth Development Council shall be lodged with the Marilao Local Youth Development Office (MLYDO).

SECTION 6. SECRETARIAT. The MLYDO shall serve as the secretariat of the Local Youth Development Council (LYDC) and shall provide technical, logistical, and other related support to the LYDC.

SECTION 7. FILLING IN OF VACANCY. Any vacancy in the membership shall automatically be filled in by the successor duly elected or appointed by the respective organization to which he or she belongs, if applicable, and who shall serve only for the unexpired term. The concerned organization must submit the name of the successor to the Office of the Mayor, the DILG-Marilao and the Sangguniang Bayan for their information and guidance. The name of the successor will be *ipso facto* included in Section 1 of this Order.

SECTION 8. REPEALING CLAUSE. – All previous orders and issuances inconsistent with the provisions of this Order are hereby repealed or modified accordingly.

SECTION 9. EFFECTIVITY. – This Executive Order shall take effect immediately.
