WHEREAS, the Municipal Mayor presented to this August Body a Letter of Endorsement entitled: *A resolution authorizing the Municipal Mayor Atty. Jemina M. Sy, for and in behalf of the Municipal Government of Marilao, to enter into a Memorandum of Agreement (MOA) with the Federation of Marilao Tricycle Operators and Drivers Association (FEMATODA, Inc.) for the purpose of enhancing Tricycle Inspection, regulations, and compliance within the Municipality of Marilao, Province of Bulacan.* for its appropriate action;

WHEREAS, the Municipality of Marilao is mandated to regulate and ensure the roadworthiness, safety, and compliance of public utility tricycles operating within its jurisdiction;

WHEREAS, FEMATODA possesses the technical expertise and resources necessary to assist in the inspection, documentation, and certification of said tricycles;

WHEREAS, the said agreement aims to recognize interconnected and complementary nature of services given to TODA Members and also giving authority to the duly elected TODA Presidents to inspect, examine, and look over in the tricycle unit subject for application of Motorized Tricycle Operators Permit after having been complied in Article VI Physical Requirements and Equipage for Tricycle for Hire, Section 36 and 37 of the Municipal Tricycle Code of Marilao;
