WHEREAS, the Municipal Mayor Honorable Atty. Jemina M. Sy presented to this August Body an Endorsement Letter entitled "*A resolution authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, to implement Local Budget Circular No.165 of the Department of Budget and Management (DBM) dated July 18, 2025 entitled "Implementation of the Second Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to Executive Order (EO) No. 64, S. 2024" in the Municipality of Marilao, Province of Bulacan*" for its appropriate action;

WHEREAS, Executive Order No. 64, s. 2024 provides the updated Salary Schedule for Civilian Government Personnel to ensure an effective, competitive and sustainable Compensation and Position Classification System (CPCS) in order to attract, retain and motivate competent and dedicated civil servants;

WHEREAS, the implementation of the Second Tranche of the Modified Salary Schedule in Local Government Unit shall subject to the authorization from the Sanggunian, as provided under Sections 447 (a), 458(a), and 468(a) of RA No. 7160;

WHEREAS, the implementation of the Second Tranche of the Updated Salary Schedule in the Municipality of Marilao shall be effective on September 1, 2025;
