WHEREAS, Honesto M. Carinan III, President of **Kabalikat Civicom Association, Inc.** has expressed intention to be accredited and eventually become partner in any local government undertaking;

WHEREAS, **Kabalikat Civicom Association, Inc.** has complied with all the requirements for accreditation with its **SEC Registration No. ANO-94-399**;


RESOLVED FURTHER, that a copy of this resolution be furnished to the Municipal Mayor and all other concerned parties for their information and appropriate action.
