WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a First Endorsement for the approval of MDC Resolution No. 2025-01 regarding the Supplemental Investment Program (SIP) 2025;

WHEREAS, in Section 109 of the Local Government Code (RA 7160) of 1991 provides the formulation of long term and annual socio-economic development plans and policies by the Local Development Council (LDC);

WHEREAS, pursuant to this provision, the Municipal Development Council (MDC) has prepared the Annual Investment Program for the calendar year 2025 containing the yearly program of expenditures both for the capital and current operating requirements of the Municipal Government of Marilao that will serve as basis for the preparation of Annual and Supplemental Budgets;

WHEREAS, priority investment included in the CY 2025 Annual Investment Program need to be upgraded and to be funded out of the local funds whether these are to be generated through direct revenue or borrowings, grants, savings from previous years' operations or from other sources;
