WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled A resolution approving and adopting Municipal Development (MDC) Resolution No. 2025-02 otherwise known as, "*A resolution approving the realignment of the amount of Fourteen Million One Hundred Fifty Thousand Pesos (P14, 150,000.00) from the Twenty Percent (20%) Development Fund of 2025 Annual Investment Program to fund certain projects of the Municipality of Marilao, Bulacan.*" for its appropriate action;

WHEREAS, in Section 109 of the Local Government Code (RA 7160) of 1991 provides the formulation of long term and annual socio-economic development plans and policies by the concerned Local Development Council (LDC);

WHEREAS, pursuant to this provision, the Municipal Development Council (MDC) has prepared the 2025 Annual Investment Program (AIP) approved under MDC Resolution No. 2024-03 dated May 13, 2024 containing the 2025 yearly program of expenditures both for the capital and current operating requirements of the Municipal Government of Marilao that will serve as a basis for the preparation of Annual and Supplemental Budgets;

WHEREAS, Section 287 of RA 7160 requires each Local Government Unit to appropriate in the Annual Budget at least 20% of the National Tax Allotment (NTA) for Development Projects;

WHEREAS, programs and projects in the 2025 Annual Investment Program to be funded out of the 20% Development Fund does not include some priority projects detailed attached to as "Annex A" of MDC Resolution No. 2024-03 which requires funds realignment of said development funds;


