**RESOLUTION AUTHORIZING THE MUNICIPAL VICE MAYOR, HONORABLE ARIEL P. AMADOR, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, AS TEMPORARY OFFICIAL SIGNATORY AS ACTING MUNICIPAL MAYOR IN ALL BUSINESS TRANSACTIONS WITH THE LANDBANK OF THE PHILIPPINES AND APPROVING CONTRACTS, ENDORSEMENTS, AND OFFICIAL CORRESPONDENCE FROM SEPTEMBER 09, 2025 TO SEPTEMBER 20, 2025.**

**WHEREAS**, the Municipal Mayor Honorable Atty. Jemina M. Sy presented to the Municipal Vice Mayor a Memorandum No. JS2025-26 on September 5, 2025, with a Subject "Designating as Acting Municipal Mayor from September 9, 2025 to September 20, 2025;

**WHEREAS**, in accordance with the R.A. 7160, also known as Local Government Code: "*Section 46. (c) When the incumbent local chief executive is traveling within the country but outside his territorial jurisdiction for a period not exceeding three (3) consecutive days, he may designate in writing the officer-in-charge of the said office. Such authorization shall specify the powers and functions that the local official concerned shall exercise in the absence of the local chief executive except the power to appoint, suspend, or dismiss employees*";

**WHEREAS**, there is a need of an authorization as Temporary Official Signatory for the continuous transaction with the Landbank of the Philippines-Meycauayan Branch and for approving contracts, endorsements, and Official Correspondence during the period given by the Municipal Mayor Atty. Jemina M. Sy;

**NOW THEREFORE**, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Juanito H. Santiago and upon unanimous vote;
