**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ATTY. JEMINA M. SY, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE LANDBANK OF THE PHILIPPINES – MEYCAUAYAN BRANCH FOR THE BATCH CREDITING FACILITY (BCF) USING LANDBANK PISO ACCOUNT UNDER THE GENERAL FUND FINANCIAL ASSISTANCE PROGRAM, ALSO KNOWN AS “PONDO PARA SA ISKOLAR NG BAYAN NG MARILAO, BULACAN,” AND TO FACILITATE THE OPENING OF INDIVIDUAL ACCOUNTS FOR APPROXIMATELY SIX THOUSAND THREE HUNDRED (6,300) SCHOLARS IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, the Municipal Mayor Honorable Atty. Jemina M. Sy presented to this August Body a Letter of Endorsement entitled “A resolution authorizing the Municipal Mayor Atty. Jemina M. Sy, for and in behalf of the Municipal Government of Marilao, to enter into a Memorandum of Agreement (MOA) with the Landbank of the Philippines – Meycauayan Branch for the Batch Crediting Facility (BCF) using Landbank Piso Account under the General Fund Financial Assistance Program, also known as “Pondo para sa Iskolar ng Bayan ng Marilao, Bulacan,” and to Facilitate the opening of Individual Accounts for approximately Six Thousand Three Hundred (6,300) Scholars in the Municipality of Marilao, Province of Bulacan.” for its appropriate action;

**WHEREAS**, the said agreement shall apply to the opening of account for LGU Marilao, student scholar beneficiaries who are eligible and do not have an existing account, in order to open a Land Bank Piso Account, receiving scholarship grants from LGU Marilao using the Land Bank Batch Credit Facility thru the Land Bank Piso Account;

**WHEREAS**, the Municipality of Marilao put great importance on education as it is one of the priority projects in the Municipality of Marilao and considering the convenience of its constituent;

**WHEREAS**, the purpose of the said ATM cards in the Municipality of Marilao is for cashless transactions thus, scholars or their parents will no longer have to go to the set place during the schedule of Financial Assistance Distribution and they could check their balance of their ATM using mobile application and may withdraw their financial assistance every 7<sup>th</sup> of May and 7<sup>th</sup> of December every year;

**NOW THEREFORE**, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Juanito H. Santiago and upon unanimous vote;

**BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to approve the above-mentioned resolution of this Honorable Sangguniang Bayan of Marilao, Bulacan.

**RESOLVED FURTHER**, that the beneficiaries of the Iskolar ng Bayan will be removed in case that they are apprehended on pawning their ATM cards to any lender institution or person.

**RESOLVED FINALLY**, to furnish copies of this Resolution to all concerned parties for their information and appropriate action.
