SY, TO ENTER INTO AND SIGN, FOR AND ON BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, THE PARTNERSHIP AGREEMENT WITH THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA), THE PROVINCIAL COOPERATIVE AND ENTERPRISE DEVELOPMENT OFFICE (PCEDO), AND THE MARILAO MUNICIPAL COOPERATIVE DEVELOPMENT COUNCIL (MCDC), TO STRENGTHEN THE COORDINATION, CAPACITY-BUILDING AND INSTITUTIONAL SUPPORT FOR THE COOPERATIVE SECTOR WITHIN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, the Acting Municipal Mayor Honorable Ariel P. Amador presented to this August Body a Letter of Endorsement entitled "A Resolution authorizing the Municipal Mayor Honorable Atty. Jemina M. Sy, to enter into and sign, for and on behalf of the Municipal Government of Marilao, the Partnership Agreement with the Cooperative Development Authority (CDA), the Provincial Cooperative and Enterprise Development Office (PCEDO), and the Marilao Municipal Cooperative Development Council (MCDC), to strengthen the coordination, capacity-building and institutional support for the cooperative sector within the Municipality of Marilao, Province of Bulacan." for its appropriate action;

**WHEREAS**, Article XII, Section 15 of the 1987 Constitution of the Republic of the Philippines stated that "Congress shall create an agency to promote the viability and growth of cooperatives as instruments for social justice and economic development";

**WHEREAS**, Republic Act No. 6939 created the Cooperative Development Authority (CDA) as the lead government agency for the promotion, development, and regulation of cooperatives in the Philippines;

**WHEREAS**, Republic Act No. 11364 otherwise known as the Cooperative Authority Charter of 2019, further strengthened the CDA's mandate and institutionalized the participation of local government units and cooperative development councils;

**WHEREAS**, Republic Act No. 11535 mandates the appointment of Cooperative Development Officer in municipalities, cities, and provinces, thereby enhancing the role of local government units in advancing cooperative development;

**WHEREAS**, the Provincial Government of Bulacan, through the Provincial Cooperative and Enterprise Development Office (PCEDO), the Municipal Government of Marilao, through the Municipal Council (MCDC), in partnership with Cooperative Development Authority (CDA), recognize the necessity of strengthening coordination, capacity-building, and institutional support for cooperative sector within the Municipality of Marilao;

**NOW THEREFORE**, on motion of Councilor Juanito H. Santiago, duly seconded by Councilor Wilfredo D. Diaz and upon unanimous vote;

**BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to approve the above-mentioned resolution of this Honorable Sangguniang Bayan of Marilao, Bulacan.

**RESOLVED FURTHER**, that a copy of this Resolution be furnished to the Municipal Mayor and all other concerned parties for their information and appropriate action.
