**WHEREAS**, the Acting Municipal Mayor Honorable Ariel P. Amador presented to this August Body a Letter of Endorsement entitled "Resolusyon na nagtitibay sa Kapasiyahan Blg.07, Serye 2025 ng Municipal Disaster Risk Reduction and Management Council na may pamagat na "Kapasiyahang nagtataas/nag-aalis (Lift) ng State of Calamity sa Bayan ng Marilao, Lalawigan ng Bulacan na idineklara sa bisa ng Municipal Resolution No. 2025-67 bilang tugon sa rekomendasyon ng MDRRMC sa pamamagitan ng kanilang Resolution No.06, Series of 2025" for its appropriate action;

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local unit shall exercise the powers expressly granted, and those essential to the promotion of the general welfare of its inhabitants;

**WHEREAS**, Typhoon Crising and Southwest Monsoon (Habagat) caused widespread devastation and damage to houses, infrastructure, properties, and agriculture, and resulted in the disruption of critical lifelines of Filipinos in areas affected by the said typhoon;

**WHEREAS**, on July 23, 2025, the 12<sup>th</sup> Sangguniang Bayan ng Marilao declared its full support to the declaration of Municipality of Marilao be under a State of Calamity and upon recommendation of Municipal Disaster Risk Reduction and Management Council through its Resolution No. MDRRMC-06 Series of 2025;

**WHEREAS**, on September 18, 2025 the Sangguniang Bayan received a letter from the Office of the Mayor endorsing the MDRRMC Resolution No.07, Series of 2025 dated August 11, 2025, recommending that the State of Calamity be lifted based on its assessment that is no longer necessary to maintain the declaration since the situation in the Municipality of Marilao has significantly improved;

**WHEREAS**, the Sangguniang Bayan may issue a declaration and lifting of the State of Calamity upon the recommendation of the LDRRMC, based on the results of the damage assessment and needs analysis as stated in Section 16 of R.A. 10121 also known as the Philippine Disaster Risk Reduction and Management Act of 2010.

**NOW THEREFORE**, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Divina E. Reyes and upon unanimous vote;

**BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to approve the above-mentioned resolution of this Honorable Sangguniang Bayan of Marilao, Bulacan.

**RESOLVED FURTHER**, that a copy of this Resolution be furnished to the Municipal Mayor and all other concerned parties for their information and appropriate action.
