WHEREAS, the Acting Municipal Mayor Honorable Ariel P. Amador presented to this August Body a Letter of Endorsement entitled "*A resolution authorizing the Municipal Mayor, Hon. Atty. Jemina M. Sy, to take appropriate legal action against Bureau of Internal Revenue (BIR) assessment for taxable year 2017 and to represent the Municipality of Marilao, in filing of a case before the Court of Tax Appeals and to sign appropriate pleadings*" for its appropriate action;

WHEREAS, the Municipality of Marilao request for reconsideration on the Final Decision on Disputed Assessment (FDDA) rendered by the Regional Director Gerry O. Dumayas of Revenue Region No.5 -Caloocan City dated November 3, 2021 demanding the payment of the total amount of ₱3,573,569.41, representing deficiency expanded withholding tax, withholding tax - valued-added tax, and withholding tax on compensation, inclusive of compromise penalty, for the taxable year 2017;

WHEREAS, the Municipality of Marilao protest against the Formal Letter of Demand/Final Assessment Notice (FLD/FAN), but upon the review of the subject protest the BIR resolves to deny the same;

WHEREAS, the Municipal Mayor Honorable Atty. Jemina M. Sy, plead a reconsideration through Motion to Admit Petition for the review of the Declared Assessment Notices by the Bureau of Internal Revenue (BIR) in the Municipality of Marilao, Province of Bulacan.
