WHEREAS, the Acting Municipal Mayor Honorable Ariel P. Amador presented to this August Body a Letter of Endorsement entitled "A Resolution Requesting All Business Establishments, Factories, Industries, and Similar Enterprises within the Municipality of Marilao, Bulacan to Give Hiring Preference and Priority to Qualified and Bona Fide Residents of Marilao in the Recruitment and Employment of Workers." for its appropriate action;

WHEREAS, pursuant to Section 16 of RA 7160, otherwise known as the Local Government Code of 1991, states that: "*xxx. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, xxx, promote full employment among their residents, xxx.*";

WHEREAS, there is a need to address the growing problem of unemployment of residents in the Municipality of Marilao, in spite of the presence and/or existence of many business establishments within the Municipality such as factories, stores, shops and the likes;

WHEREAS, to accomplish its aforesaid mandate, the Municipal Government of Marilao must require that, in the hiring of job applicants by the business establishments within the municipality of Marilao, preference be given to actual and bona fide residents of Marilao;

NOW THEREFORE, on motion of Councilor Maria Luisa I. Silvestre, duly seconded by Councilor Juanito H. Santiago and upon unanimous vote;

BE IT RESOLVED AS IT IS HEREBY RESOLVED, to require all business establishments, factories, industries, and similar enterprises within the Municipality of Marilao, Bulacan to give seventy percent (70%) of hiring preference and priority to qualified and bonafide residents of Marilao in the recruitment and employment of workers.

RESOLVED FURTHER, that copies of this Resolution be distributed by the BPLO to the business establishments in Marilao, Bulacan upon application or renewal of their Business Permit.

RESOLVED FINALLY, that a copy of this Resolution be furnished to the Municipal Mayor and all other concerned parties for their information and appropriate action.
